Short Description:

The Fund is an open-ended peso-denominated long-term bond fund suited for clients with an Investor Profile of Moderate. The investment objective of the Fund is to generate a steady stream of income by investing in a diversified portfolio of high-grade marketable securities with portfolio duration of over five (5) years.

Administrative Details:

Trust Fee: Total amount of trust fee for the 1st quarter of 2014 amounted to Php 13,847.85

Minimum Investment: Php 25,000.00

Holding Period: 90 days

Admission and Redemption of Participation:

1. Admission/participation in the Fund shall always be through participation in units of the Fund and each unit shall have uniform rights or privileges as any other unit. The beneficial interest of each participation unit shall be determined under the Net Asset Value ("NAV") per unit valuation methodology defined in the Declaration of Trust ("DOT").
2. Redemption - full redemption is allowed subject to the terms and conditions set forth and by endorsing and surrendering the Report of Participation ("ROP"). Partial redemption is currently not allowed.

4. Corporate Notes/ Bonds with PRS Rating of "AAA" to "A" or its equivalent as allowed under the BSP Rules subject further to the approval by the Trust and Investments Committee.
