FUND TRANSFER OF OWN ACCOUNTS

ONLINE, PAPER-LESS, & REAL-TIME

Have the option to initiate data entry transactions or upload a file for multiple transactions. You can also select when your transactions shall be processed - whether real-time, same-day or post-dated.

For 3rd Party Account crediting, voucher details may be provided when you initiate your instructions. Your payees will also be notified through email once crediting is successful and may view available credit voucher.

Conveniently provide your credit instruction or simply use our template to transfer funds anytime and anywhere with instant reconciliation! Feel free to also download transaction reports.

You may initiate Fund Transfer -Own transaction by following the steps below:

- Go to BankCom Business website and log in your credentials.
- Once logged in, choose the Fund Transfer Own Account module under the Funds Management menu then choose your pre-enrolled deposit account on the drop down list. Select the receiving account and place the amount you'll transfer. You can also initiate a fund transfer instructions via file uploading,
- You may also indicate additional transaction details in the Remarks portion which you can view in the Account Transaction History and reports.
- All transactions shall require workflow approval prior to processing. Once fully approved, amount shall be credited to your selected receiving account.

Start a Fund Transfer - 3rd Party Account now:

- Enroll your beneficiary accounts in the payee maintenance module using these 3 key details: Payee Code, Payee Name, and Beneficiary Account. No need for Bank's approval.
- Upload a payment instructions file securely online, or easily create through data entry screen.
- All transactions shall require workflow approval prior to processing. Once fully approved, funds are automatically credited to the 3rd party beneficiary account.
- Access various reports that can be downloaded.

 Beneficiary accounts will also get notified via email once transaction is successful.

INSTAPAY

- File and authorize your instructions online through the BankCom Business platform. Note that instructions can also be post-dated!
- Once the instructions are fully authorized, your selected funding account gets debited and the credit instructions shall be relayed to the receiving bank/s based on the type of Fund Transfer Other Bank option you'd choose (Instapay or Pesonet).
- After a successful transfer, you may view the status of your instruction and your payee will be notified via email.
