For Corporate Access Enrollment:

- 1 Go to our eGov services link: www.bancnetonline.com/egov/login.egov
- 2 Select the government facility you wish to be enrolled in and provide the Corporate Administrator, including your Customer Access Number (CAN) issued by BankCom.
- 3 Create the users such as the maker, checker and approver, to start making payments.
- 4 We'll review your CAN and activate it once it has been approved.

For Filing and Payment:

- 1 The maker on your company's end will upload the contributions or loan payment files to Bancnet eGov's website.
- 2 The assigned checker will review the maker's instructions.
- 3 The approver should approve the transaction and encode the CAN and the PIN to authorize debit from your company's account.

Avail our BIR Electronic Filing and Payment System (eFPS):

For e-Filing:

- 1 Go to BIR's eFPS website: efps.bir.gov.ph, and select a BIR tax return form to fill it out.
- 2 Once you've filled up the form, choose Bank of Commerce as the transacting bank. You'll then be redirected to BancNet Online Tax Payment Gateway.

For e-Payment:

- 1 Provide the payment instruction that will be routed to workflow approval prior to processing.
- 2 The final authorizer will then encode the CAN and PIN to go through with the payment.
- 3 Once the tax payment instruction has been approved, you'll receive a payment confirmation.
